10.01 Working in partnership with parents/carers and other agencies

Little Doves CP believes that families are central in all services we provide for young children. They are involved in all aspects of their child's care, their views are actively sought and they are actively involved in the running of the pre-school in various ways.

Partnership with local and national agencies is encouraged to promote the well-being of all children.

Families

- When referring to 'parents', this means both mothers and fathers; these include both natural or birth parents as well as stepparents and parents who do not live with their children but have contact with them and play a part in their lives. 'Parents' also includes same sex parents as well as foster parents.
- Parents/carers are provided with written and verbal information about the pre-school, including the pre-school's safeguarding actions and responsibilities under the Prevent Duty. Every effort is made to ensure that parents/carers understand the information that is given to them and help with filling in the forms, if required, is provided.
- Parents/carers are made to feel welcome in the pre-school; they are greeted appropriately, there is adult seating and provision for refreshment.
- Every effort is made to accommodate parents/carers who have a disability or impairment.
- The expectations from parents/carers are made clear at the point of registration in the 09.01c Little Doves Christian Pre-school Parent and carer contract.
- There is a clear expectation that parents/carers will participate in settling their child at the commencement of a place according to an agreed plan.
- There is sufficient opportunity for parents/carers to share necessary information with staff and this is recorded and stored to protect confidentiality.
- Parents/carers are involved in the shared record keeping about their children either formally or
 informally and parents/carers have access to their children's written developmental records.
 Parents/carers are made aware of the 07.06 Data protection and privacy notice that details how and
 why their personal information is processed. This is available on the Little Doves website.
- Parents/carers are consulted about the times of meetings to avoid excluding anyone and meetings are held in venues that are accessible and appropriate for all.
- Key persons support parents/carers in their role as the child's first and most enduring educators.
- Key persons regularly meet with parents/carers to discuss their child's progress and to share concerns
 if they arise.
- Key persons work with parents/carers to carry out an agreed plan to support a child's special educational needs.

- Key persons work with parents/carers to carry out any agreed tasks where a child protection plan is in place.
- According to the nature of the pre-school, there is provision for families to be involved in activities that
 promote their own learning and well-being, informing parents/carers about relevant conferences,
 workshops and training.
- Parents/carers are involved in the social and cultural life of the pre-school and actively contribute.
- As far as possible the service is provided in a flexible way to meet the needs of parents/carers without compromising the needs of children.
- Parents/carers are involved in regular assessment of their child's learning and development progress, including the progress check at age two, see procedure 09.14 Progress check at age two.
 Parents/carers are also offered the opportunity to have an appointment to view their child's "Big book of me" learning journal.
- There are effective means for communicating with parents/carers on all relevant matters and 10.02
 Complaints procedure for parents/carers and service users is referred to when necessary.
- Every effort is made to provide an interpreter for parents/carers who speak a language other than English and to provide translated written materials.
- Information about a child and their family is kept confidential within the pre-school. The exception to this is where there is cause to believe that a child may be suffering, or is likely to suffer, significant harm, or where there are concerns regarding their child's development that need to be shared with another agency. Parental permission will be sought unless there are reasons not to, to protect the safety of the child. All this is explained on the 09.01b Registration, Sessions Requested and Permission Form.
- Parental consent is sought to administer medication, take a child for emergency treatment, take a child
 on an outing and take photographs for the purposes of record keeping.
- Parents/carers views are sought regarding changes in the delivery of the service.
- Parents/carers are actively encouraged to participate in decision making processes.
- There are opportunities for parents/carers to take active roles in supporting their child's learning in the
 pre-school: informally through helping out or activities with their child, or through structured projects
 engaging parents/carers and staff in their child's learning.

Agencies

- The pre-school works in partnership or in tandem with local and national agencies to promote the wellbeing of children.
- Procedures are in place for sharing of information about children and families with other agencies, as set out in procedures 07.02 Confidentiality, recording and sharing information and 07.06 Data protection and privacy notice.

- Information shared by other agencies (third party information) is also kept in confidence and not shared without consent from that agency.
- When working in partnership with staff from other agencies, individuals are made to feel welcome in the pre-school and professional roles are respected.
- Staff follow the protocols for working with agencies, for example, on child protection.
- Staff from other agencies do not have unsupervised access to the child they are visiting in the preschool and do not have access to any other children during their visit.
- Staff do not casually share information or seek informal advice about any named child/family.
- We consult with and signpost to local and national agencies who offer a wealth of advice and
 information promoting staff understanding of issues facing them in their work and who can provide
 support and information for families. For example, ethnic/cultural organisations, drug/alcohol agencies,
 welfare rights advisors or organisations promoting childcare and education, or adult education.

Schools

- The pre-school works in partnership with schools to assist a child's transition (as set out in 09.13 Prime times Transition to school) and share information (as set out in 07.04 Transfer of records).
- The pre-school manager actively seeks to forge partnership with local schools with the aim of sharing best practice and creating a consistent approach.
